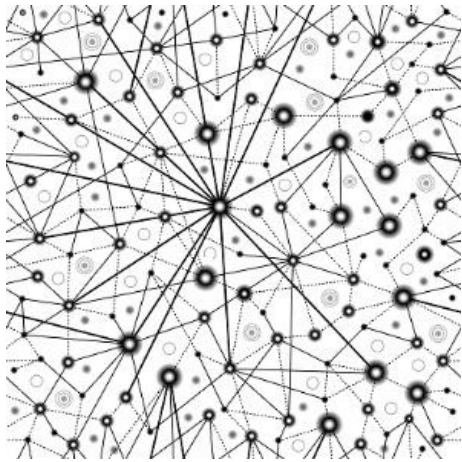
Key Findings

- Improved internal processes leading to a better understanding of the business

A Proposed Future Generations Bill



Key elements:

- the future long term economic, social, environmental wellbeing of Wales.
- Organisations will have to demonstrate how they have prioritised what they do and how they spend their money.

Key principles:

- integration and collaboration;
- long term thinking and a focus on prevention;
- evidence and citizen centred.
