Staff details and structure

I am writing in response to your request for information of 18 November 2020 in which you requested information regarding staff contact details and an up to date senior structure chart.

For ease of reference, I have reproduced your **questions below** and set out our corresponding responses:

I am withholding the details of all other staff (or those with equivalent job titles) under s40(2) of the Freedom of Information Act as this is the personal data of the role holders and disclosure would breach the data protection principles of the Data Protection Act 2018. This is an absolute exemption. In withholding this information, I have considered the ICO guidance on the disclosure of personal data https://ico.org.uk/media/for-organisations/documents/2614720/personal-information-section-40-and-regulation-13-version-21.pdf and its guidance on requests for information about public authority employees https://ico.org.uk/media/for-

organisations/documents/1187/section 40 requests for personal data about e mployees.pdf. These roles are middle management or junior roles, and not publicly available. These staff do not hold specific responsibility for the spending of public funds – this rests at a higher level in the organisation.
